


CANTYS BUS RENTALS - HIRE TERMS AND CONDITIONS:

- 1) **THE HIRER AGREES TO HIRE A VEHICLE ON THE TERMS AND CONDITIONS OF THIS AGREEMENT**
- 2) THE HIRER AGREES THAT
 - a) Drivers must have the appropriate Australian licence to drive the vehicle as required by law. A copy of licence is required.
 - b) No P-Plate or L-Plate drivers allowed. No International licence drivers.
 - c) LR or above driver's licence required for buses with more than 12 seats
 - d) That neither he/she nor anyone else who drives the vehicle be under 21 years of age or 80 years of age and over.
 - e) He/she or any other driver who operates the vehicle will only do so if permitted by law.
 - f) The vehicle will not be used for any illegal purpose or carry more passengers or load than that for which it was designed.
 - g) That he/she has told the owner accurately what the vehicle will be used for and where it will be going. Excess charges apply otherwise.
- 3) **Damage excess: Pantech truck \$3000, 20+ seat buses \$3000, All other vehicles \$550.** Excess applies per vehicle on all accidental damage including windscreen/glass damage. The hirer is responsible for total costs of repairs for: overhead roof/Pantech damage, all tyre/wheel/snowchain damage, any damage caused by neglect, deliberately, maliciously or recklessly, damage caused on unsealed roads and any damage otherwise caused whilst the vehicle was being used outside of the terms of this agreement. Any excess reduction listed on front page. Vehicle to be driven on sealed roads at all times.
- 4) The customer may also be liable for demurrage in the event the vehicle is not available for normal hire as a consequence of damage or an accident
- 5) **The hirer is responsible for the total cost of vehicle damage, third party property damage and bodily injury if the driver of the vehicle is under 21 years of age or over 80 years of age or driving under the influence of alcohol or prohibited drugs**
- 6) Canty's Bus Rentals will not be responsible for any loss or damage to any property stolen from the vehicle or otherwise lost during the rental period.
- 7) The hirer is responsible for checking the suitability of connecting portable electrical/electronic devices, and non-Cantys vehicle trailers to vehicle power sources eg cigarette lighter sockets, trailer electrical sockets. The hirer agrees to waive any claim for damage or loss occasioned to the hirer for such devices used in/with the vehicle. Note: 21+ Seater buses, Pantech's are 24Volt
- 8) No smoking permitted in vehicles. A \$550 non-compliance fee will apply.
- 9) Vehicles must be returned in opening hours. Open Mon-Fri 7:30am; Sat/Sun 7am. A \$200 out of hours return fee will apply.
- 10) A reasonable cleaning fee may be charged if the vehicle is returned: in an unclean state; with alcoholic drink spillage or smell
- 11) A refueling fee of \$3.50 per litre will be charged for refueling part empty vehicle fuel tanks. Fuel gauge to read over F(full)
- 12) Refuel to the very top of the fuel tank due to foaming air lock
- 13) A \$30.00 administration fee will apply to each motorway toll charge referred to Canty's Bus Rentals. Note that toll operators will charge their own administration fee. Traffic infringements incur a minimum administration fee of \$30
- 14) Canty's Bus Rentals give no warranties as to the condition of the vehicle except those implied by law and gives no warranties as to the suitability or fitness of the vehicle for any person
- 15) The hirer agrees to waive any claim for loss or damage occasioned to the hirer because of: delays, booking and service errors, mechanical failure of the vehicle, lost or stolen personal items, accidents or any other events
- 16) The hirer is responsible for checking and maintaining engine oil and water levels and tyre pressure. Failure to do so will render the hirer responsible for any loss or damage
- 17) The hirer is responsible for the fitting and use of child seats and restraints to the vehicle.
- 18) Canty's Bus Rentals have the right to terminate this hire agreement and recover the hired vehicle at any time without refund.
- 19) Cancellation notice: Minimum 48 hours before hire required for a full refund else all payments forfeited. No refunds or credits after a hire has started.
- 20) Buses are fitted with GPS tracking and electronic tachographs which monitor position and speed.
- 21) Banks etc will take a minimum 3 to 5 business days to process credit card refunds into customer's bank account.
- 22) Callouts for non-breakdown service eg locked keys, lights left on, out of fuel & tyre repairs etc will incur a NRMA callout fee
- 23) Offensive or unruly behaviour towards the other motorists or the general public will result in loss of security bond
- 24) **MOTORWAY TOLL: A \$30 ADMIN CHARGE APPLIES TO EACH TOLL CHARGE REFERED TO CANTY'S BUS RENTALS**
- 25) **I hereby authorise Cantys Bus Rentals to charge vehicle damage, fuel, extra hire, toll, admin, cleaning fees, non-breakdown/tyre callouts etc to my credit card/cash security bond.**
